

Because You Can't See Sterile, Be Sure with Sure-Check:

- **Secure Seal** Extra wide chevron to protect against instrument breaching.
- 3 **Medical Grade Paper** Wet strength treated, virgin medical grade paper that meets medical pouch standards.
- 4 **Transparent Film** Allows a clear view of the contents as well as the internal indicators.
- of strip securely seals pouch and provides sterilization integrity of contents during storage. Contents will remain sterile for three years provided the integrity of the pouch is not compromised.
- 6 **Perforated Fold** Allows for accurate folding of adhesive strip to form an airtight seal, maintaining the integrity of the pouch during storage after sterilization.
- **Complete Film/Paper Separation** The high quality of the materials and manufacturing process assures a consistently clean separation (peeling) of the film from the paper, maintaining the sterile integrity of the contents.
- 8 **Thumb Notch** Assures easy opening of pouch.
- Orner Tack Seals Three tack seals on each corner prevent curling and possible separation after sterilization. In addition they prevent the collection of dust and other contaminants in the sealed area.
